Jacob Victorian Leisler [JVL], Jacob's father, was born on March 14, 1606, in Oettingen, Swabia, Bavaria, Germany, the youngest son of Dr. Jacob Leisler and Maria Magdalena Stahel. He attended the universities of Altdorf and Geneva. In 1626 the Geneva German Reformed Church ordained him; he became minister of that congregation in 1632. In 1634 he enrolled at the University of Basel to pursue postgraduate studies. In August of that year he married Susanna Adelheid Wissenbach (1612–1694), a daughter of Geneva Academy regent and professor Heinrich Wissenbach (1583–1666) and Catharine Aubert (1584–1674). In 1635 JVL accepted a call by the Frankenthal, Rhineland-Palatinate, French Reformed community. In 1636 Spanish occupiers forced him to flee to Kreuznach. The following year the Frankfurt-am-Main French Reformed community worshipping in Bockenheim called him to be its minister. The Reverend Leisler died in Frankfurt on February 4, 1653.
